Purpose of Membership

The FYILI Private Membership Association provides members access to a local Long Island marketplace, community commerce features, business listings, member offers, purchaser opportunities, and related website services.

Membership is based on a straightforward market relationship between FYILI, participating businesses, vendors, purchasers, and members.

Joining the PMA

By registering, submitting payment if required, or using member-only features, you agree to join the FYILI PMA and follow these Membership Guidelines.

- Be at least 18 years old;
- Provide accurate registration and contact information;
- Review and accept the PMA Membership Agreement;
- Follow all payment, purchase, listing, and website rules;
- Use FYILI for lawful marketplace and purchaser activity only.

Remaining in Good Standing

To remain a member in good standing, you agree to:

- Keep your account information accurate and current;
- Pay any membership, listing, or purchase fees when due;
- Communicate honestly with FYILI, vendors, purchasers, and members;
- Submit only accurate business, product, service, event, or listing information;
- Respect the privacy, property, and rights of other members;
- Use the website for legitimate marketplace, business, and purchaser purposes;
- Follow all posted FYILI policies, checkout terms, and payment rules.

Marketplace Conduct

Members may not use FYILI to post, submit, promote, or distribute content that is false, misleading, unlawful, abusive, defamatory, spam-related, infringing, or unrelated to the marketplace purpose of the website.

FYILI is a commerce-focused platform. Non-marketplace commentary or advocacy content may be declined, removed, or restricted.

Purchases and Vendor Responsibility

FYILI may provide access to business listings, offers, promotions, marketplace features, and member opportunities. Unless clearly stated otherwise, third-party businesses and vendors are responsible for their own products, services, prices, delivery, refunds, representations, and customer service.

Purchasers are responsible for reviewing purchase details before completing a transaction.

Content and Listings

Members who submit listings, business information, photos, offers, or other content confirm that they have the right to submit it and that the information is accurate.

FYILI may approve, edit, reject, or remove submissions to maintain quality, accuracy, relevance, and marketplace standards.

Payment and Cancellation

Members agree to the payment terms shown at checkout. Membership renews automatically, the renewal amount, billing frequency, and cancellation method will be shown before payment is submitted.

Cancellation stops future charges but does not automatically refund past payments unless required by law or approved by FYILI.

Suspension or Removal

FYILI may suspend or remove a member, listing, post, or account if the member fails to pay, provides false information, misuses the website, violates these Guidelines, or acts in a way that harms the marketplace or member experience.
